The Structural Engineering team manages the risk to the structures by ensuring a sound balance between structural reliability and optimal use of the assets by applying appropriate margins of safety with due regard to the structures' strategic importance and economic consequences of failure.

Arqiva is committed to maintaining high standards of professionalism in Structural Engineering. To meet our commitments, we:

- Adopt best practice and relevant health and safety legislation and commit to maintaining the health, safety and wellbeing of our employees and all our stakeholders affected by our operations in alignment with the requirements of BOH695.
- Commit to minimising the environmental impact of our activities, products and services (where practicable) in alignment with the requirements of BOH684.
- Ensure our assets are designed, constructed and operated to standards that promote good safety performance throughout their life including decommissioning.
